These filing fees are in addition to state filing fees and are due upon submission of an application. Failure to pay the local fee at the time of filing shall result in the application being deemed incomplete.

Notice of Intent (NOI)	Projects that are at least 75 feet from <u>all</u> resource areas - \$50;	50
	Minor project (house addition, tennis court, swimming pool, utility work, septic system upgrade which meets Title V requirements for setbacks to wetlands, repairs to existing piers, docks, and coastal engineering structures)	110
	Single family home (including accessory structures, driveways and utilities)	500
	Multiple dwelling structure (including accessory structures, driveways and utilities)	1,050
	Subdivisions (roads, utilities and stormwater management only)	1,050
	Commercial and industrial projects	1,050
	New piers, docks, and coastal engineering structures - \$4 per linear foot, not less than \$100 or more than \$2,000	\$4 / linear foot
	New septics, or repair of existing system which does not meet Title V requirements for setbacks to wetlands	50
	Resource area enhancement [pursuant to 310 CMR 10.53(4)]	50
	Dredging activities (not associated with pier or dock construction)	1,450

Additional Fees for NOIs	An additional \$300 fee will be charged if the project requires wetland replication as a result of direct wetland impacts, or requires filling of Land Subject to Flooding	300
	Any work proposed in a Resource Area (those listed under Sections 9.3 through 9.7 of the Regulation), in the No Disturb Zone or Structures proposed in the No Build Zone shall be charged 1.5 times the applicable rate(s) as listed above.	1.5 x
After the Fact Filings	All permit applications filed <u>after</u> the work has begun will be charged <u>double</u> the appropriate filing fee.	2.0 x
